	This membership is available to former NCCC members only. Any requests for such status shall be directed to the Club, Regional Membership Director, or VP of Membership. Associate members need not comply with the Corvette ownership or recognized club membership requirements set forth in Section 1 of the Bylaws. An Associate member shall be entitled to all of the privileges of Primary members except the right to hold office in NCCC or compete for National or Regional points.

MEMBER-AT-LARGE	\$35.00 initial fee for new member. \$10.00 for new Spouse / Companion. \$25.00 for renewing member. \$10.00 for renewing Spouse / Companion member.
	An MAL is any person who is not a member of a recognized club, but who otherwise meets the requirements of membership. Any requests for such status shall be directed to the Regional Membership Director or the VP of Membership. Members at Large shall not be entitled to vote or hold office in the Corporation.
SPONSOR	Sponsors are individuals or corporations that provide financial or alternate forms of support to NCCC.
DUES TERM	The dues period covers January 1 to December 31; however, because the NCCC system must process all member renewals before December 15, dues must be paid and received by the VP of Membership on or before December 15 in order to allow time for the processing procedure to take place before the following year begins.
